1996 Mentorship with Dr. Sullivan

I began by learning hands on the Provocative/Neutralization Technique, the methodology used for testing and treating food, mold, inhalant, hormone, metal, chemical, and neurotransmitter allergy/sensitivity. This type of testing can specifically target the root cause/causes of a symptom.

1996 Mentorship with Woodlands Healing Research Center, Quakertown, Pennsylvania

Previous to my hire, Dr. Sullivan had been mentored by Harold Buttram, MD, FAACP at Woodlands. I subsequently began a mentorship program with Dr. Buttram's Allergy Technician, Mark Alsup, CMT, Allergy Lab Supervisor. Training included: Serial Endpoint Titration, Multi Antigen Food Allergy Testing, allergy treatment: including mixing treatment vials, injection titration and injection technique, elimination/challenge diets, reintroduction diets and scientific food families.
